President Dr M.B.Aswathnarayanan calls the house to order. Welcomes all the office bearers. Asks the Hon. Gen. Secretary. Dr. Sabyasachi Saha to proceed with the meeting. Dr. Sabyasachi saha welcomes all the office bearers and starts the proceeding as per the agenda.

### **Regarding approval of minutes of the 8th EC meeting held on 12.05. 2017 board Room Annexe Block Balaji Vidyapeeth University, Pondicherry.**

Hon. Gen. Secretary. Dr. Sabyasachi Saha informed that as the minutes were circulated earlier and as there were no queries expressed, it may be approved .EC unanimously approves.

### **Action taken report of the 8<sup>th</sup> EC meeting.**

**Upcoming National Conference2017-** Received email from Dr Samir Patil Principal Sinhgad dental college- Regarding change of venue from Pune to Dhule citing administrative reasons and same is circulated to EC for necessary action.EC approves the change of venue.

**PG Convention Coorg audit report-2016-** Letter of reminder has been sent, received audit report only.EC after going through the audit report felt that the amount received is less than the 10% of the registration amounts .EC recommends to write a letter for the same to Dr Jitesh Jain.

**National Conference 2016 Bhubaneswar-**Twice letter of reminder has been sent to Dr Avinash,So far Head office has not received the audited account statement and 10% head office share.EC uniamously felt to write a letter to the principal and vice chancellor of the kalinga university regarding the same.President Dr.M.B.Aswathnarayanan and Hon. Gen. Secretary. Dr. Sabyasachi Saha expresses that such a delay should not be repeated in the forth coming conferences and strict adherence to the national conference protocol laid by IAPHD Dr Arun Dodamani organising chairman of IAPHD 22<sup>nd</sup> National conference assures the EC that 10% HO share will be disbursed as per IAPHD rules and regulations.

Vice President Dr.Vamsi Krishna Reddy brings it to the notice of EC that an ESCROW account between IAPHD head office and conference organisers should be made so that automatically HO share will be remitted into the account of IAPHD HO immediately after registration from delegates. Hon. Gen. Secretary. Dr. Sabyasachi Saha suggests talking with bankers for feasibility of such an account.

**Regarding UG practical examination of Public Health Dentistry Maharashtra-**as per the directions of EC Dr Arun Doddamani to spoke to the Dean of Dental Faculty MUHS immediately in person and subsequently Dean of Dental Faculty MUHS has assured all necessary measures will be taken so that both the examiners will be from the speciality of public health dentistry.

**As per agenda:**

**1. Scientific committee proceedings:** Dr Arun S Doddamani scientific committee chairman along with Dr Sowmya, Dr Archana and their team had already submitted a detailed proposal as well as report. The scientific study was assigned to the scientific committee to know the best toothpaste and tooth brush to be recommended for general population for routine use based on the scientific evidence. Regarding the same, the scientific committee selected 08 toothpaste and 10 tooth brush keeping various attributes in mind. Based on the evidence of prepared check list these toothpastes and toothbrushes were further recommended for clinical trial. Details of Phase-I trial of the toothpaste and results have been circulated to all the office bearers through secretary. All the expenses incurred during the study were borne by scientific committee by themselves. Dr Arun S Doddamani Dr Sowmya and Dr Archana expressed not much contribution has been received from all the scientific committee members

President Dr Aswathnarayanan suggests the said protocol for the trail on toothpaste and tooth pastes to be conducted in 3 centers who volunteered earlier i.e Dr Arun Doddamani from ACPM dental college Dhule, Dr PG Naveen Kumar from CODS Davangaere and Dr Vrinda Saxena from Peoples Dental College and get necessary ethical clearance approval from their respective institutions. The validated checklist for toothpastes and toothbrushes for the trail will be submitted for forthcoming EC for approval.

**Letter from scientific committee-IAPHD financial assistance for research grants-** Hon. Gen. Secretary. Dr. Sabyasachi Saha suggests to circulate the guidelines for research grants for UG ,PG and Faculty to all members inviting the scientific proposal.EC recommends the scientific committee to go through the scientific proposals received and shortlist the same so that grants can be made available to the deserving in the next EC meeting.

**2. Faculty Development Program-**on behalf Dr Pushpanjali , Dr.Vamsi Krishna Reddy brings it to the notice of EC letter had been to be issued seeking any institution interested in hosting this event. But as of now only two colleges have made an enquiry into this one is Balaji Vidayepeth University Pondicherry and other was Coorg institute of dental sciences. EC suggests Dr Pushpanjali to further communicate with them and make necessary arrangements to carry out the program at least twice a year in different zones.

**3. To enter into the Guinness book of records for tooth brushing on national tooth brushing day** to enable it as a national IEC activity- President brings it to the notice of the EC that after going through the relevant information regarding the gunnies book of records registration process and discussing with other associations that this entire process incurs a cost of 4.8lakhs approximately if it is taken up a third party who are professional in this matter. Vice President Dr.Vamsi Krishna Reddy enquires whether the cost will be reduced if we do the entire procedure by ourselves, president informs that the cost incurred will be more and time consumed will be more if we do it by ourselves.

Hon. Gen. Secretary. Dr. Sabyasachi Saha suggests as all the colleges especially the institutes where the pg in dept of public health dentistry are there can raise some fund at least 3000Rs/per institute as the institute and Department will be part of the gunnies records. President Dr.M.B.Aswathnarayanan suggests all the institutes which are participating will be provided with a letter of appreciation and participation certificate from the association. EC welcomes the move and suggests writing a letter to all the institutes and other agencies for financial aid.

Dr. Sabyasachi Saha appreciates the proposal and to make detailed report by Dr Pushpanjali ,who shall be convener of the project and same shall be submitted to dental council of India,if the council approves the proposal than this program can be carried under DCI –IAPHD joint venture.
